LEGAL REGULATIONS IN CONNECTION WITH SALE, USE AND STORAGE

CHLOORSTABIL BE-REG-00257 is a pesticide for non-agricultural use, class A (see RD 22 May 2003 concerning the marketing and the use of biocides). The product may only be sold by a registered salesman of biocides and be applied by a certified user of biocides. Also professional use, as stipulated by the Ministerial Order of 6 March 2002, or the maintenance of a private swimming pool is allowed.

The packing, which contains CHLOORSTABIL BE-REG-00257, must be kept in a closed room, exclusively destined for the storage of biocides.

The room must be dry, efficiently ventilated, in a good condition of maintenance and cleanliness. The room must be so arranged that the good preservation of the product is assured. On the outside of the door of this room, the mention "poison" and a "skull" pictogram must be visible.


SHELF LIFE

To minimize loss of activity it is advisable to keep the sodium hypochlorite solution in a cool and dark storage, not in direct sunlight.

Shelf life 1 month after production date.

After 1 month check the concentration of the product to determine if the product still complies for the application. On base of the concentration check, the dose can be adjusted.
